

# PEANUT AND TREE NUT ALLERGY PROCEDURE AT FOREST PARK

**ALL TREATS FOR PEANUT/TREE NUT SAFE CLASSROOMS MUST BE CHECKED BY THE NURSE BEFORE ENTERING CLASSROOM.**

A. PEANUT/TREE NUT SAFE TABLE in LUNCH ROOM

1. Place "Peanut/Tree Nut Safe Table" signs on the table closest to the wall. (replace when necessary)
2. Only students that buy school lunch can sit at the "Peanut/Tree Nut Safe Table".
3. Bringers must sit at the second section closest to the kitchen.
4. Custodians are to use separate cleaning supplies for the "Peanut/Tree Nut Safe Table".

B. PEANUT/TREE NUT ALLERGY CLASSROOM PRECAUTIONS:

1. Have a "NO PEANUT/TREE NUT PRODUCTS ALLOWED" sign outside door of classroom.
2. Send clinic letter to parents who have students in a "NO PEANUT/TREE NUT PRODUCTS ALLOWED" classroom. Include PEANUT/TREE NUT SAFE SNACKS list with letters to parents.
3. Remind parents periodically in newsletter about safe snacks
4. WHEN EATING TOGETHER IN THE CLASSROOM:
  - Students should sit at their own desks for lunch.
  - All students will wash their hands after eating.

**WHEN USING FOOD PRODUCTS AS PROPS OR REWARDS IN EDUCATIONAL SETTINGS THEY MUST BE PEANUT/TREE NUT SAFE.**

**REMINDER: ALL TREATS FOR PEANUT/TREE NUT SAFE CLASSROOMS MUST BE CHECKED BY THE NURSE BEFORE ENTERING CLASSROOM. A STICKER WILL BE PLACED ON THE TREATS AFTER THEY HAVE BEEN CHECKED BY THE NURSE. THOSE SNACKS THAT ARE NOT PEANUT/TREE NUT SAFE WILL NOT BE ALLOWED IN THE CLASSROOM. THE CLINIC WILL CALL THE PARENTS AND SEND THE SNACK HOME UNOPENED.**

C. BEFORE AND AFTER SCHOOL CLUBS:

1. Review Allergy List provided by clinic with students in club.
2. Refer to PEANUT/TREE NUT SAFE snack list

**BEFORE CLASSROOM PARTIES TEACHERS WITH PEANUT/TREE NUT SAFE CLASSROOMS WILL REVIEW ALLERGIES WITH ROOM MOTHERS. THEY WILL ALSO REVIEW THE SAFE SNACK LIST. ON PARTY DAY THE SCHOOL NURSE WILL CHECK THE SNACKS FOR THOSE CLASSROOMS BEFORE SERVING.**
